

## **RISHTEY BIRTHDAY WISH**

1. The following are the terms and conditions governing the on-going birthday wishes activity titled "**RISHTEY BIRTHDAY WISH**" ("Contest") to be organised by JioStar India Private Limited [formerly Star India Private Limited] ("JioStar" / "JioStar India") which is to be held on the Channel and Website (defined hereinafter) from 1<sup>st</sup> January, 2026 ("Start Date").
2. These Terms and Conditions apply to all parents/legal guardians ("You" / "Participant(s)") who intend to participate in the Contest. Your participation in the Contest constitutes Your agreement to follow and be bound by these Terms and Conditions, JioStar's policies hosted at <https://www.jiostar.com/legal-terms-policies/>, cookie policy available at <https://cdn.colorsrishtey.com/wp-content/uploads/2026/01/Cookie-Policy-Colors-Rishtey-Microsite.pdf>, and Privacy Policy (available at <https://cdn.colorsrishtey.com/wp-content/uploads/2026/01/Privacy Notice Colors Rishtey Birthday Wishing.pdf>) and incorporated herein by reference (collectively referred to as "T&Cs") without modification, and all other operating rules, policies and procedures that may be published from time to time by JioStar India. If You do not agree to the T&Cs, You are advised not to participate in the Contest. Please be advised that if You choose to continue to participate in the Contest, it shall be deemed that You have accepted the T&Cs. The T&Cs are personal to You, and are not assignable, transferable or sub-licensable by You.
3. Eligibility criteria: This Contest is open to all Participants who comply with the following:
  - a) are parents/legal guardians of children upto 15 years of age and are citizens of India and are residing in India;
  - b) are viewers of the channel "Colors Rishtey" ("Channel");
  - c) do not have criminal conviction or an arrangement or a contract that prevents the Participant(s) from participating in the Contest.
  - d) Since the age criteria prescribed is upto 15 (fifteen) years, participation by minors will be deemed as participation with the prior unconditional consent and knowledge of the Participant's parents/legal guardian. It is made abundantly and evidently clear that such Participants are participating in the Contest with the consent and assistance of their parents/legal guardians. Accordingly, the Participants shall provide all the necessary documents/proof as required by JioStar upon its request in this regard. The validity of such proof shall be determined by JioStar at its own discretion.
  - e) Are parents/legal guardians of children who have their birthdays commencing 1 (one) month after the Start Date;
4. Submission mechanism: A Participant may participate in the Contest by following below steps, during the Contest Period (defined below):
  - a) To participate in the Contest, a Participant must (i) strictly meet the eligibility criteria set out hereinabove and must send in their i) child's photograph, their own name, child's name, their own e-mail id, child's date of birth, city/village, and State as per the mode of participation provided herein below and strictly in compliance with the Contest T&Cs set out herein ("Contest Entry").
  - b) Each Participant shall be permitted to send only 1 (one) Contest Entry. The Participant agrees and confirms that the entire contents of their Contest Entry, shall be their own, and the Participant shall at no time furnish any data/information (including personal or

personally identifiable information) which belongs to any third party. The Participant hereby agrees and confirms that the Contest Entry is in compliance with all the applicable laws, does not violate any right of any third party, including any intellectual property rights, privacy rights, personality rights etc., and does not contain any confidential information. Participant further understands that any such Contest Entry by the Participant is voluntary, and at his/her sole discretion and is not mandatory.

- c) JioStar shall have the right to disqualify any Contest Entry containing any defamatory/derogatory information.
- d) the Participants must submit only those Contest Entries where the date of birth falls within the succeeding one (1) month from the date of submission of the Contest Entry and only such Contest Entries will be collected for the purpose of this Contest. Any Contest Entries made more than 1 (one) month in advance from the birth date mentioned in the Contest Entry will not be considered and shall be disqualified. By way of an illustration, Participant shall submit his/her Contest Entry no earlier than in June 2026 if the birthday falls in July 2026. Any advance entries earlier than the same shall stand disqualified.
- e) Post the Start Date, the Contest Entry must be submitted by the Participant at least 7 (seven) days in advance of the applicable birthday month mentioned in the Contest Entry. Late entries will not be considered and will stand disqualified. By way of example, for a birthday which falls on 7<sup>th</sup> February, 2026, the Participant must submit the Contest Entry by 1<sup>st</sup> February, 2026.

## 5. Mode of Participation:

- a) A Participant shall be required to send in the aforesaid Contest Entry by either of the following mode(s) of participation:
  - i) Website Participation (Fill in the Form): The Participant may participate by uploading the Contest Entry on the Channel's official website at the URL <https://www.colorsrishtey.com/> ("Website") by clicking on the "Birthday Wishes" tab, uploading the Contest Entry, subject to acceptance of these T&Cs, and thereafter press the "SUBMIT" button; OR
  - ii) Social Media/Channel participation (promotional posts): The Participant shall be required to scan the QR code displayed at the end of the promotional material aired on the Channel, and official social media handles of JioStar to participate in the Contest. After scanning the QR code, the Participant will be redirected to the Website to upload the Contest Entry and shall be simultaneously required to "Accept" or "Not Accept" these T&Cs.
- b) Only those Participants who have accepted the T&Cs by selecting the "I Accept/ I consent" option will be entitled to participate in this Contest.
- c) Once the Participant has accepted the T&Cs, as mentioned above, he/she shall be able to subsequently submit their Contest Entry.

- d) Participants who have not accepted the T&Cs shall not participate in the Contest or share any personal or personally identifiable information with JioStar in any manner whatsoever.
- e) Once the Contest Entry(ies) has/have been sent as per the above steps, the submission of the Contest Entry shall stand complete, and no further Contest Entry(ies) will be considered from the same Participant for the same child.
- f) Any Contest Entry made more than 1 (one) month in advance of the applicable birthday month shall not be considered for the purpose of this Contest.

6. All the Contest Entries will be considered valid only if the Participant submitting the same strictly complies/meets the eligibility criteria, submission mechanism, and mode of participation set out in Clauses 3, 4, and 5 of these T&Cs.
7. Contest Entries submitted for a specific birthday month as mentioned in the Contest Entry will remain valid only for that month.
8. All Contest Entries (including those which are not shortlisted) will be permanently deleted within 7 (seven) days from the beginning of the calendar month immediately following the birthday month mentioned in the Contest Entry and will no longer be stored/processed/or considered.
9. Each Participant shall ensure that the Contest Entry submitted by such Participant for the purpose of this Contest shall be with appropriate permissions/ no-objections permitting such Participant to share such Contest Entry, including without limitation, the photograph of the child of the Participant and their personal details with JioStar and further permitting/ licensing JioStar to broadcast it on its Channel and Website owned or controlled by it and/or all such modes, media and format as may be determined by JioStar and in no manner infringe any rights including intellectual property rights, including without limitation, the copyright of such third person(s)/ other party, venue, etc. and subject to Clause 15 (Grants of Rights and License to JioStar) and Clause 16 (Specific Representation and Warranties of all Participants) below and other terms and conditions herein.
10. The Participant represents and warrants that he/ she has the unconditional right, permission, consent and authority to participate and submit the Contest Entry and to grant JioStar the right to broadcast the Contest Entry, including without limitation the photograph of the Participant's child along with his / her name and other details required for participation in the Contest, on its Channel and Website and all such modes, media and formats determined by JioStar at its discretion.
11. By participating in the Contest and accepting and agreeing to the T&Cs and generally as part of the submission mechanism, the Participant hereby exclusively, irrevocably and unconditionally assigns all copyrights and other intellectual property rights relating to the Contest Entry (including without limitation all exploitation rights thereof across all modes, mediums, formats, platforms and technologies, whether in existence now; or in existence now, but not in commercial use on the date of execution hereof; or are developed in future) for the territory of the entire world till the time the Contest is complete, in favour of JioStar, on and with effect from the date of submission of the Contest Entry. The Participant acknowledges and

confirms that he/she shall, at his/her own cost and expense, obtain all requisite assignments, licenses, permissions, authorizations, no-objection certificates, written arrangements, etc., from the all other persons and entities so as to ensure exclusive, irrevocable, and unconditional assignment of all copyrights and other intellectual property rights relating to the Contest Entry for the territory of the entire world for the Purpose (defined below) till the time the Contest is complete, in favour of JioStar in the manner contemplated herein above.

12. The Participant hereby agrees that the provisions of Section 19(4) of the India Copyright Act, 1957 as amended from time to time shall not apply to the above assignment by the Participant. The Participant hereby expressly waives his/her rights under the said section and further, represents that he/she has entered into valid written agreements whereby the copyright assignments and waivers have been obtained by it, from all authors/ contributors of the underlying works comprised in the Contest Entries.
13. By participating in the Contest, each Participant unconditionally agrees, acknowledges, and confirms that: (i) JioStar shall have complete rights (as described above including but not limited to download the Contest Entry to edit, alter, modify, or combine the Contest Entry or any parts thereof, to ensure that the Contest Entry complies with the technical specifications, and is otherwise suitable for exhibition to the general public, and for ensuring compliance with any applicable censorship or other laws anywhere in the world and to store the Contest Entries on its server or such other servers as may be authorized by JioStar as prescribed under the applicable laws; and (ii) in lieu of the license of the rights in the Contest Entry as aforesaid, the Participant shall not claim any payments or raise dispute on usage by JioStar of the same. Any breach or violation of sub-clause (ii) above by the Participant shall amount to breach of these T&Cs by the Participant and entitle JioStar to all such rights and remedies as mentioned in these T&Cs and as under applicable laws and equity.
14. The Participant grants to JioStar, his/her irrevocable consent to use the Contest Entries (entirely or in part) along with their name, child's name, child's photograph, child's birth date and required details, for the purpose of wishing the child in the Contest on the Channel and the Website ("Purpose").
15. Grant of Rights and License to JioStar: Participant appreciates JioStar's concern that any examination of the Contest Entries, without a full release of liability, might expose JioStar to claims or threat of litigation. Therefore, as an inducement for JioStar's examination and evaluation of the Contest Entries, and in consideration of such examination, and without prejudice to the declarations provided herein or as may be required by JioStar from time to time, the Participant hereby acknowledges and agrees as follows:
  - a) Its submission of the Contest Entry to JioStar is voluntary, is not solicited by JioStar, and not in confidence.
  - b) There is no agreement between JioStar and the Participant or any third party, express or implied, relating to JioStar's use or failure to use the Contest Entry or any part thereof.
  - c) The Participant shall not assert against JioStar, its affiliates, licensees, assigns, officers, agents or employees any claim of any nature arising out of any alleged use by JioStar of the Contest Entries or any part thereof.

- d) The Participant will not hold JioStar responsible for any loss, theft of the personal information, or any part thereof, including without limitation, the name, photographs, etc.
- e) The Participant hereby agrees to indemnify and keep indemnified JioStar, its officers, directors, employees, representatives, affiliates, promoters, etc. from any and all claims in respect of any aspect of the Contest Entries as submitted by the Participant, or any of the intellectual property rights thereof, or the assignment thereof, or privacy or publicity, property rights or of any other claims, as well as claims from any third person(s) associated in any manner with the Contest Entries, or any claims arising from the breach/ violation of any of the foregoing terms and conditions and/ or any claims in relation to Participant's participation in this Contest.

16. Specific Representation and Warranties of Participants: Each Participant represents, and warrants the following:

- a) his/her participation is voluntary with his/her own free will and consent and is not forced to participate in this Contest;
- b) Contest Entry(ies) shall be suitable for presentation in a public forum, in sole determination of JioStar.
- c) Contest Entry(ies) shall not be in breach of any third-party rights including but not limited to any rights in any copyrighted works and underlying works, that it shall in no manner infringe any rights including but not limited to the copyright trademark, privacy, publicity or other personal or proprietary rights of JioStar and/ or any third person/ party.
- d) the Contest Entry is not obscene, vulgar, defaming, denigrating women, offensive/insensitive, hurting religious/moral/social/political sentiments of any individual/groups/association, depicting violence, or against the morality/public policy of India or/ and the internal policies of JioStar.
- e) Contest Entry(ies) shall not promote or advertise any product(s), service(s) or brand(s).
- f) Contest Entry(ies) shall not contain content that depicts alcohol or tobacco or drugs.
- g) Contest Entry(ies) shall not in any manner depict or encourage harm or injury to any person, party, animal.
- h) Contest Entry(ies) shall not contain text, images or artwork not owned by the Participant.
- i) No license fee, royalties, charges, etc. are payable to any person/party/copyright society anywhere in the entire world, in relation to the Contest Entry and the same is rights clear.
- j) The Contest Entry(ies) are not and will not be uploaded/ publicized by Participants in any manner including on social networks/websites/blogs nor be discussed with any party, including without limitation the press, about any information relating to this Contest, the video, participation/appearance, or any other information which may come to the knowledge

of the Participants, including without limitation in relation to JioStar or any of its employees, consultants or vendors.

- k) He / she has the unconditional right and authority to participate and submit the Contest Entry and to grant JioStar the right to broadcast on its Channel and Website and all such modes, media and formats determined by JioStar at its discretion, the Contest Entries that may be submitted and such other details as may be submitted to participate in the Contest for the Purpose.
- l) JioStar shall have complete rights including but not limited to download the Contest Entry to edit, alter, modify, combine the Contest Entry or any parts thereof, to ensure that the Contest Entry complies with the technical specifications, and is otherwise suitable for exhibition to the general public, and for ensuring compliance with any applicable censorship or other laws anywhere in the world and to store the Contest Entries on its server or such other servers as may be authorized by JioStar; and that in lieu of the license of the rights in the Contest Entry as aforesaid, the Participant shall not claim any payments or raise dispute on usage by JioStar of same.
- m) He/she acknowledges that JioStar shall not be liable for any mishap, injury, accident, untoward incident, physical harm of any nature, death, loss of life or limb, etc., caused to them, either before, during or after the Contest; and the same shall not be attributed to JioStar and JioStar shall not be held responsible towards the same nor shall be liable to indemnify or make good any claim being raised against it, for whatsoever nature.
- n) In the event of any violation of the aforementioned representations, warranties, or undertakings, JioStar may in its sole discretion disqualify the Contest Entry from the Contest with immediate effect. By participating in the Contest, the Participants also represent and warrant that he/she shall solely be liable for any and all action (criminal/civil) arising therefrom, whether in India or internationally, and shall also be liable to indemnify JioStar and any of its licensees etc. for any loss, claim, dispute, disruption caused to them.

17. The Shortlisted Participants (defined below) shall be announced/displayed twice on the Channel/Website between 8:00 am to 13:00 pm on the birth date appearing in the Contest Entry of the Shortlisted Participant in a mode as deemed appropriate at sole discretion of JioStar.

18. Selection of Shortlisted Participants: JioStar shall select not more than 10 (ten) Participants each day on a first come basis who, (i) have submitted the Contest Entry in accordance with the Contest T&Cs, as determined by JioStar in its sole discretion; and (ii) strictly meet the eligibility criteria set out in Clause 1.3 of these T&Cs, as the shortlisted participants of the Contest who will be eligible for the Gratification ("Shortlisted Participants"); and (iii) have submitted the Contest Entries in accordance with clauses 4 and 5 above. Notwithstanding the foregoing, the Participants agree that JioStar reserves the right to determine the final number of Shortlisted Participants, at its sole discretion and without any protest or demur from the Participants. It is clarified that JioStar shall not be obligated to (but shall have the right) shortlist another Contest Entry in place of any forfeited/disqualified entries. The decision of JioStar shall be final and binding in this regard and the Participant shall not challenge the same in any manner whatsoever. Further, JioStar shall be under no obligation whatsoever to share or disclose, inter-alia, any methodology/parameters used in shortlisting or selecting the Shortlisted Participants.

19. Gratification will be announced every day on the Channel and Website twice during 08:00 a.m. – 01:00 p.m. or such other time as determined by Jiostar in its sole discretion, subject to compliance of the T&Cs herein and all instructions of Jiostar from time to time.
20. Participants may tune into the Channel and the Website during 08:00 a.m.- 01:00 p.m. on the day of the birthday to find out if the Contest Entry was shortlisted for the birthday wishes.
21. Gratification Details:
  - i) Out of all the Participants who have participated in the Contest, not more than 10 (ten) or such number of Contest Entry(ies) as determined by Jiostar at its sole discretion shall be shortlisted on the basis of random selection by Jiostar or by any third party engaged by Jiostar for the purpose of posting the birthday wishes on the Channel/Website at no fees/costs payable to the Participant or any third party.
  - ii) The Shortlisted Participants of the Contest (as declared by Jiostar) would be eligible to win an opportunity to feature in a “Happy Birthday Video” on the Website and shall also be wished via “aston bands” on the Channel during the respective birthday month mentioned in the Contest Entry of the Shortlisted Participants (“Happy Birthday Wish”) (““Gratification”).
  - iii) For the sake of clarity, it is understood that each Shortlisted Participant of the Contest (as selected and declared by Jiostar) shall be eligible for 1 (one) Gratification each being a one-time opportunity to feature in a “Happy Birthday Wish” as mentioned in clause (ii) above , subject to the terms and conditions mentioned herein and at sole discretion of Jiostar.
  - iv) Further, each Gratification set out above shall be determined by Jiostar in its sole discretion. Without prejudice to the aforesaid, the nature, form, specifications, duration and other elements comprising the Happy Birthday Wish shall be as determined by Jiostar in its sole discretion. Jiostar shall have the right to modify the nature of the Gratification (or any item / element comprising the same) or the T&Cs pertaining to the same without assigning any reason for the same and Jiostar shall not be held liable for the same.
  - v) The Participant agreed and understands that with regards to the “Happy Birthday Video” which shall be displayed on the Website, the Participant irrevocably consents to the name and photograph shared by the Participant for the Purpose being combined/integrated in a creative video.
  - vi) The Participants or any third party shall have no right to question the nature, form, specification, type or number of the Gratification being given by Jiostar.
  - vii) Jiostar takes no responsibility, liability or any other expenses for the Shortlisted Participants eligible to receive the Gratification.

22. The Participant further agrees and acknowledges that, nothing in this clause shall deem to cast any obligation on JioStar to telecast or display the Contest Entry, or any part of it, on its Channel/Website/social media handles etc., and the same maybe done at JioStar India's sole discretion.
23. The Participant hereby expressly consents to use of the Contest Entry by JioStar or any third party engaged by JioStar for the purpose of this Contest, and hereby agrees and acknowledges that the use and storage of such Contest Entry is necessary for the completion of the said Purpose.
24. Notwithstanding anything contained herein, JioStar shall have the right to disqualify any Participant / Shortlisted Participants in case (i) the photograph submitted by such Participant as part of the Contest Entry is not their own or is not of appropriate quality, clarity and / or resolution and / or (ii) the details provided by the Participant especially the date of birth is incorrect.
25. The Participants/Shortlisted Participants acknowledge that JioStar shall not be liable for any costs, expenses, charges, fees, taxes, etc. incurred by the Participants/Shortlisted Participants in participating in the Contest, and the Participants/Shortlisted Participants shall be absolutely responsible and solely liable for the same.
26. The Participants shall not be entitled to the Gratification simply by reason of participating in the Contest. Only upon complying with all T&Cs mentioned herein, to the satisfaction of JioStar, shall the shortlisting be validated. Further, the Shortlisted Participants so selected shall be entitled to the Gratification as set out herein above. The selection process may be revised and shall be as per JioStar's sole discretion. The Participants or any third party shall have no right to question the process of selection.
27. The Participants hereby agree and undertake that mere participation in the Contest shall not entitle them to the Gratification.
28. In the event of unforeseen circumstances beyond the control of JioStar, and the Gratification not being made available to the Shortlisted Participants, the Shortlisted Participants shall not have the right to claim any damages or monies from JioStar and by participating in this Contest the Shortlisted Participants waive their right to make any claims against JioStar.
29. JioStar shall not be responsible for the quality or deficiency etc. of the Gratification and no claim or request, whatsoever, in this respect shall be entertained by JioStar.
30. Employees of JioStar and/or their associate and affiliate companies/ concerns and/ or sponsors will not be qualified for Gratification in the Contest.
31. JioStar reserves the right to change/ modify T&Cs and/ or criteria of the Contest and / or the Gratification for the Contest and/ or the duration/ timing of the Contest, at any time at their own discretion and without any prior notice and without assigning any reason.
32. JioStar shall not entertain any questions, correspondence, enquiries on the manner of conduct of the Contest and grant of the Gratification from any party whatsoever.

33. Apart from the entitlement to the Gratification, the Shortlisted Participant or his/her legal heirs will have no other rights or claims against JioStar.
34. The Participant acknowledges that he/she will not hold JioStar and/ or any of its affiliates or agencies engaged by them with regard to this Contest liable for any loss or opportunity, monetary loss due to their participation in the Contest.
35. JioStar shall not be responsible for any loss of entries for any reason, whatsoever including, due to any problems caused by telephone lines, service providers, network breakdowns, computer service delays, interruptions, network failures or overloads, or for lost, misdirected or misplaced entries, or for entries received after the Contest Period; or for Gratification not reaching the Shortlisted Participants due to any reasons; or for any reasons beyond the control of JioStar.
36. JioStar is not responsible for any errors or omissions in the T&Cs contained herein. All information provided in the Contest is provided "As is" without warranty of any kind. JioStar makes no representations and disclaims all express, implied and statutory warranties of any kind to the viewer/Participant and/or any third party including, without limitation, warranties as to accuracy, timeliness, completeness, merchantability, or fitness for any particular purpose.
37. Under no circumstance, shall JioStar and/or their directors, employees, officers, affiliates or subsidiaries, be liable to the Participant and/or any third party for any lost profits or lost opportunity, indirect, special, consequential, incidental, or punitive damages whatsoever, even if JioStar has been advised of the possibility of such damages. The Participant specifically agrees not to file in person/through any family member and/or any third party any applications, criminal and/or civil proceedings in any courts or forum against JioStar and/or their directors, employees, officers, affiliates or subsidiaries to claim any damages or relief in connection with the Contest.
38. The Participants hereby agree and undertake that they shall not accept or undertake to accept or give or undertake to give, either directly or indirectly, any gifts, commission or other favor, of any kind whatsoever, to facilitate their participation/ winning the Contest. Any knowledge of such an act shall lead to immediate disqualification of such Participants and JioStar shall be entitled to take any and all action(s) against such Participants, as deemed fit by it.
39. To enable registration of a Participant , personally identifiable information which shall include without limitation name, date of birth, photograph, email address, etc. of the Participant and/or Shortlisted Participant ("Personal Information") may be collected by JioStar to enable the JioStar to administer and promote this Contest. If Participants/Shortlisted Participants do not truthfully provide all requested Personal Information, JioStar may determine that such Participants/Shortlisted Participant are not eligible to win the Gratification in this Contest. . the Personal Information of the Participant/Shortlisted Participant shall be provided by JioStar to the extent allowed by law, to others assisting JioStar in this regard, including its affiliates, associates, authorities, agents, sponsors, employees, prize suppliers, distributors, deliverers and service providers (as applicable).
40. The T&Cs of and in relation to this Contest as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This is a legal and binding agreement between the Participant and JioStar, that states the terms that govern the Participant's participation in the Contest through the

Platform. By making the Contest Entry, the Participant agrees to have read and understood the terms and conditions and hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the terms and conditions stated herein.

41. Notwithstanding anything contained herein, the Participants, of the Contest who are selected and eligible for the Gratification (as detailed herein) hereby acknowledge, affirm and agree that they have read, understood, accept and hereby agree to abide by all terms and conditions of this Contest. Without prejudice to the aforesaid and for the avoidance of doubt, it is stated that all T&Cs of this Contest shall apply mutatis mutandis to the Shortlisted Participants who are selected and may be eligible for the gratification in accordance with the terms and conditions stated herein.
42. In case of any dispute or difference in respect of this Contest, the decision of Jiomart shall be final and binding on all concerned.
43. The Contest shall be subject to jurisdiction of competent court/s at Mumbai alone.
44. The decision of the Jiomart in connection with the Contest will be final & binding and is non-contestable.
45. All decisions of Jiomart shall not be subject to any appeal of any nature whatsoever. By participating in the Contest, it shall be construed that the Participant has waived his/her right to dispute the Contest and/or any decision(s) made by Jiomart in relation to this Contest.
46. The Participants shall not under any circumstances make any claims against Jiomart or Jiomart's affiliates/entities/representatives arising out of or relating to any and all costs, injuries, losses or damages of any kind, including, without limitation due to any technical faults or directly or indirectly, to the participation or non-participation in the Contest or any related activity. If any Participant is found to be ineligible, or if he or she has not complied with these terms and conditions, their participation will not be considered further.
47. Jiomart may at its sole discretion extend or curtail the Contest Period or may suspend or abandon the same at any time without any prior notice of the same. In such event, Jiomart shall not be liable to any Participant in any manner whatsoever.
